All sheep will be sold in guineas and in catalogue order unless any alteration is authorised and announced by the Auctioneers.

The sale is held subject to the LAA Conditions of Sale in addition to the Auctioneers General Conditions of Sale.

## SETTLEMENT AND CLEARANCE OF STOCK:

Settlement in full is due to the Auctioneers immediately at the close of the sale. No animals will be permitted to leave the premises without an official pass obtainable upon settlement.
